- c) other competitors/participants may ride dangerously or with lack of skill;
- d) track or event conditions may be hazardous and may vary without warning or predictability;
- e) the Organisers/Managers, officials, landowners/track operators and any agents or representatives of those in charge at Manar Off Road Park are frequently obliged to make decisions under pressure of time and/or events;
- f) any policy of insurance of or in respect of the Minor's life or physical or mental health may be voided;
- g) there may be no or inadequate facilities for treatment or transport of the Minor if injured; and
- h) entrants including the Minor have an obligation to themselves and to others to compete/ride safely and within the event guidelines.
- 4. In consideration of the Organiser's/Managers accepting the Minor as a participant in activities at Manar Off Road Park I agree to indemnify the Guardian, the Organiser's/Managers and each of them in the following manner:
